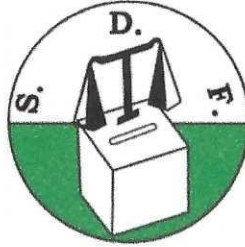

**RESOLUTIONS OF THE MEETING OF THE NATIONAL EXECUTIVE
COMMITTEE OF 10th December 2022 HELD IN YAOUNDE**

The National Executive Committee of the SDF met in Yaoundé on the 10th of December 2022 to debate and discuss on various issues related to the Party, to the nation and the international scene. During this meeting that was chaired by the National Chairman H.E. Ni John FRUNDI, the following resolutions were taken:

A- ON THE LIFE OF THE PARTY

- **Mindful of the Constitution and the Rules and Regulations of the Party;**
- **Mindful of the reports of the Presidents of the Commissions in charge of the renewal of basic party structures;**

The National Executive Committee

- Adopts the reports of the NEC commissions in charge of the renewal of basic party structures in all the regions for the work done so far at the level of the wards, the electoral districts and divisional coordinations.
- Orders article 18:8 of the party's constitution to all Regional Executive Committees except for the Southwest Region which is already working under article 18:8, and SDF-USA Region which was recently put in place in August 2022. This measure is to ensure the smooth completion of the renewal process that is ongoing.
- Congratulates the new executive of SDF USA Region.
- Decides that, following the decision to apply article 18:8 to all the regional executive committees as mentioned above, the CHAIRMEN of the various NEC commissions will be in charge of running those regions until after the holding of the Regional Conferences.

- Orders the fusion of the electoral districts of Douala 3-1 and 3-2 into one electoral district, as well as Douala 5-1 and Douala 5-2 in WOURI Division of the Littoral Region.
- Assigns Mayor Njong Donatus and Hon. Forbi Nchinda to assist in the renewal meeting to be convened in January 2023 by the chairperson of the NEC commission in charge of renewal in the Southwest region and ensure that there is harmony between the Chairperson of the NEC commission and the Coordinator of the Southwest Region.
- Instructs the National Financial Secretary and the National Treasurer to forward the necessary financial records to the internal auditors of the Party within 30 days for an audit on the accounts. The auditors have 30 days on reception of the accounting information to forward their report to the Secretary General, so that the report can be presented at the next National Executive Committee meeting.
- Frowns at those militants who misrepresent the party position especially through attacks and blackmail, or damage the reputation and image of the party or any of its members in public. Henceforth, no party member is allowed to publicly express his or her opinion in the media and be presented as SDF representative or do so on behalf of the Party without having been expressly mandated to that effect by the Secretary General and the Communication department. Any party member who fails to do so will expose themselves to serious disciplinary sanction.
- Suspend the decision to apply disciplinary sanctions on Mbvoum Mbvoum Aloys Parfait after accepting his apologies. However, the party hierarchy called him to order noting that any such recalcitrant behaviour on his part contrary to the values of the SDF shall no longer be tolerated.

B- ON THE NATIONAL SCENE

- **Considering the shortage of energy products and the rising cost of living in Cameroon;**
- **Considering the 2023 state budget that has been recently adopted by the National Assembly;**
- **Considering the numerous financial scandals surrounding the management of state finances and some Government ministers and other high ranking state officials;**
- **Considering the ongoing crisis in the Northwest and Southwest regions;**
- **Considering the security crisis in the Adamawa, East and Far North Regions;**

The National Executive Committee

- Calls on the Government of Cameroon to take appropriate measures to reduce the burden of the rising cost of living on Cameroonians who struggle just to survive on daily basis;
- Condemns the Government's lack of political will to follow up the execution of the state budget, and properly address the numerous financial scandals surrounding high ranking state officials;
- Request the Government to be accountable and transparent with the management of the emergency/miscellaneous funds of the state budget;
- Urges the Government to take a meaningful political action to bring an end to the Anglophone crisis that has so destroyed the lives of many Cameroonians particularly in the Northwest and Southwest Regions and brought untold suffering and hardship;
- Calls on the government to change strategy and undertake serious political steps to address the declining and appalling security situation in the Adamawa, East and Far North Regions of the country.


C- ON THE INTERNATIONAL SCENE

- Considering the visit of the SDF Secretary General and the Shadow Cabinet Member in charge of Finance and Economy to Ivory Coast in October 2022;
- Considering the USA-Africa summit in which President Paul Biya of Cameroon is in attendance;

The National Executive Committee

- Reaffirms the party's support towards former President Laurent Gbagbo of Ivory Coast in his political exploits and Pan African vision.
- Expects a fruitful economic and diplomatic outcome from the USA-Africa summit between the US and Cameroon, and Africa in general.
