RESOLUTIONS OF THE MEETING OF THE NATIONAL EXECUTIVE COMMITTEE OF MAY 14^{TH} 2022 HELD IN YAOUNDE

The National Executive Committee of the SDF met in Yaoundé on the 14th of May 2022 to debate and discuss on various issues related to the Party, the national and international scene. During this meeting, chaired by the National Chairman H.E. Ni John FRU NDI, the following resolutions were taken:

A- ON THE LIFE OF THE PARTY

- Mindful of the Constitution and the Rules and Regulations of the Party;
- Mindful of the reports of the Presidents of the of the Commissions in charge of Party reorganization;

The National Executive Committee

- Congratulates the Regional reorganisation commissions for the work done so far and adopts
 the reports of Centre, Far North, North West and West Regions and the Adamawa Region
 with some reserves;
- Instructs the regional commissions to conclude the reorganisation exercise latest on the 15th of July 2022 for a full report to be provided during the next NEC meeting;
- Requests the team in charge of reorganisation of the Far North to proceed with the reorganisation of the East Region together with Mayor MABANGA Paul in replacement of the late Senator KEMENDE;
- Annuls all the reorganisation done so far in the South West region and requests the NEC team leader and the South West Regional Coordinator to carry out the reorganisation process as a single team as prescribed by the circular letter of the 30th of October 2021;
- Reiterates that the NEC teams carry the responsibility of this reorganization exercise, and
 the Regional Executives should provide the necessary support for this exercise to be
 properly executed;
- Requests the National Financial Secretary and the National Treasurer to forward the
 necessary financial records to the National Secretariat within 30 days for an audit on the
 accounts. This audit report should be presented during the next NEC meeting.
- Empowers the National Chairman to co-opt members into the National Executive Committee to replace vacancies with respect to Section 18.5 of our constitution;

B-ON THE NATIONAL SCENE

- Considering the escalating high cost of living in Cameroon;
- Considering the ongoing civil war in the North-West and South-West regions;
- Considering the ongoing teacher's strike;

The National Executive Committee

- Calls on the government of Cameroon to appropriately arrest the escalation of price hikes in Cameroon, especially for basic commodities and services;
- Reiterates our position on the extremely low purchasing power faced by a majority of Cameroonians, which exposes them to price hikes, and which can be addressed via the appropriate salary increases, especially for workers with low income;
- Recalls government that salaries must be commensurate to economic growth;
- Urges government to immediately address the issue of the minimum wage and increase it to an amount that permits workers of lower wage band to live from their work;
- Calls on the government to fully embrace the opportunities imposed by the current world economic context to invest massively on import substitution;
- Condemns with the strongest possible terms the wanton killings, abductions and endless
 insecurity going on in the North West and South West regions;
- Urge government to resolve this crisis and ensure a rapid return to peace and stability in these two regions;
- Reiterates the condemnation of all forms of violence, whatever their origin, perpetrated in order to try to solve a fundamentally political problem that emerged as a result of bad governance perpetrated by the regime in place;
- Calls on government to find a definite solution to the teacher's strike and take appropriate
 actions in order compensate for students lost time;
- Calls on government to immediately launch an enquiry to understand the cause of this discrepancy and establish responsibilities;
