RESOLUTIONS OF THE MEETING OF THE NATIONAL EXECUTIVE COMMITTEE OF 17th FEBRUARY 2024 HELD IN YAOUNDÉ

The National Executive Committee of the SDF met in Yaoundé on the 17th of February 2024 to debate and discuss on various issues related to the Party, the National and International scene. During this meeting, which was chaired by the National Chairman, Hon. Joshua **OSIH**, the following resolutions were taken:

A- ON THE LIFE OF THE PARTY

- Mindful of the Constitution and the Rules and Regulations of the Party;
- Mindful of the resolutions of the 10th Ordinary Convention of the party;
- Mindful of the reports of the working Ad-hoc committees;
- Considering the reports of the various regions;

The National Executive Committee

- Requests the Secretary General to publish the resolutions of the 10th ordinary convention as soon as possible.
- Requests the legal department to integrate the resolutions pertaining to constitutional modifications of the 10th Ordinary Convention into the Parti Constitution and the internal rules and regulations of the party.
- Congratulates and adopts the reports of the working Ad-Hoc Committees in promoting the political agenda of the party in matters of public policy and asks them to continue the work until publication.
- Convenes a National Conference with the objective of bringing together officials of the party to discuss the fundamental public policy positions of the party.
- Adopts the National Chairman's plan of action and encourages him to organize a national tour.
- Request the National Chairman to put in place a team to go to Mombo in the Littoral region with the objective of investigating the controversies surrounding the Mombo council.
- Adopts the reports of the regional chairpersons and designates **Senator NGAM** Honoré as NEC envoy to the West region with the objective of bringing a lasting solution to the Bafoussam 1 electoral district crisis before the next NEC.

- Puts in place a Commission to introduce a micro health insurance policy for SDF militants who wish to participate, headed by **Hon. DJEUMENI** Benilde as the chairperson and open to co-option of further members.
- Congratulates the initiative of the National Socialist Women Coordinator of the party in organizing and bringing together the socialist women from across the national territory to strategize and forge a path to involve more women in politics.
- Reiterates that being registered on the electoral register is a precondition to be a party member.
- Calls on the electoral districts to reinforce and accelerate the registration, and wherever necessary, the transfer of voters on the electoral register.
- Calls on all Regional, Electoral and Wards Executives to accelerate the work of providing our militant database to NEC.
- Requests all Regional Chairpersons to provide the full list of their polling agents and at least 3 alternates per polling station on or before the 1st of May 2024 to NEC.
- Requests all Regional Chairpersons to provide the names and contacts of all communication secretaries in their constituencies of competence to the National Communication Secretary.
- Congratulates the Communication department and the Ad-Hoc committee on communication for the development of our brand identity, website, (www.sdf.cm) and online newsletter (The Vanguard) and adopts these propositions.

B- ON THE NATIONAL SCENE

- Considering the drastic increase in fuel prices in Cameroon;
- Considering the recommendations of the constitutional and political affairs Ad-Hoc committees of the 10th Ordinary Convention of the party;
- Considering the worsening security situation in the ongoing armed conflict in the North West and South West Regions;
- Considering the non-convening of the Higher Judicial Council since 2020;
- Taking cognizance of the poor results of our National Football Team at the just ended African Cup of Nations;
- Condemns the government's constant increase of fuel prices to finance its luxurious and exorbitant lifestyle at the detriment of the social welfare of the masses.
- Regrets the autocratic regime's inability to address the root causes of the economic woes
 of our citizens that lies in the limited purchasing power of the people.
- Encourages the National Chairman to continue building up agreements and alliances with other political parties, civil society organizations and trade unions for a strong and reliable left-wing front in Cameroon.
- Resolutely stands on the side of our citizens, workers, and fully supports our civil society partners, and in particular our trade unions in the fight against social injustices and the fight for the amelioration of the welfare of Cameroonians in general.
- Strongly condemns the barbaric bomb attack and violence on the civilian population in Nkambe in the North West region.
