# RESOLUTIONS OF THE MEETING OF THE NATIONAL EXECUTIVE COMMITTEE HELD IN YAOUNDÉ ON THE 12<sup>TH</sup> OF OCTOBER 2024

The National Executive Committee of the SDF met in Yaoundé on the 12<sup>th</sup> of October 2024 to deliberate and decide on various issues related to the Party, the National and International scene. During the meeting that was chaired by the National Chairman, Hon. Joshua OSIH, the following resolutions were taken:

#### A- ON THE LIFE OF THE PARTY

- Mindful of the Constitution and the Rules and Regulations of the Party;
- Mindful of the National Chairman's International tour in Europe;
- Considering the reports of the various regions;

#### The National Executive Committee

- Congratulates the National Chairman for his European tour and appreciate the report presented.
- Receives the decision of the Douala 3 Electoral District on the disrespect of Party investiture and confirms the decision applying article 8.2 to AZEMBA Achille. Takes cognizance of the apology letter of Roger Marie YOUMBISSIE and issues a WARNING to him.
- Congratulates Senator NGAM Honore and adopts the report of the Bafoussam 1
   Electoral District and confirms the new Bafoussam 1 Electoral District Executive
   Committee with TOUKAM André as the new Electoral District Chairperson.
- Congratulates and adopts the report of the NEC team led by Rev. Dr. FONJINDAM
   Emmanuel assigned to conduct a rerun of the district election in the Tiko Electoral
   District with TEBOH George elected as the new Electoral District Chairperson.
- Adopts the regional reports of the Adamawa, Centre, East, Far North, Littoral, North, North-West, South, South-West, West and Europe regions and congratulates the North region in particular for a job well done in providing a comprehensive list of all polling agents in the region.
- Extends its condolences to the family of late Senator Alhadji MAIKANO who passed onto eternal glory on the 10<sup>th</sup> of October 2024.
- Takes cognizance of the draft 2025 2026 SDF political programme and empowers the Secretary General to lead and compose a team that shall organize/



- the launching of this program in Yaoundé, after which the National Chairman will effect a national tour to deliver the programme to the Cameroonian people.
- Requests all Regional Chairpersons to act appropriately to ensure that their regions are actively represented in the upcoming 2026 municipal and legislative elections by working hard to ensure the availability of winning candidates.
- Reminds all Regional Chairpersons that they have to provide their complete lists
  of polling agents and their complete list of regional and electoral district executives
  with their contact phone numbers on or before November 15th 2024.
- Reminds all party members to pay their membership fee for 2024 and maintains the same rates for 2025.

#### B- ON THE NATIONAL SCENE

- Considering the postponement of the municipal and legislative elections to 2026;
- Considering the man-induced and natural catastrophes that have ushered in a severe humanitarian crisis in many parts of the country and especially in the Far North region as a result of the rampant floods;
- Considering the rumors surrounding the whereabouts of the President of the Republic;
- Considering the cacophonic outings of various government officials on the President's absence, including the ban of debates on the President's health issued by the Minister of Territorial Administration;
- Considering the ever increasing and unbearable high cost of living in Cameroon;
- Considering the disappearance of our national road infrastructure, the scarcity of water and electricity as well as the very poor service offered at a very high cost by mobile phone companies;

#### The National Executive Committee

- Condemns the repeated extension of the mandates of elected officials without a sound justification that would allow for such, which is seriously undermining our democracy.
- Strongly condemns the government's inability to properly address the alarming and worsening humanitarian crisis in the Far North region.
- Calls on the government to immediately put in place repair works for the entire Logone and Lake Maga dikes and develop, through efficient hydrographic engineering, a sustainable water containment and irrigation system.
- Reminds the government that the rumors surrounding the whereabouts of the Head of State are fueled by the fact that we have an absentee landlord.
- Condemns the ever increasing government cacophony which is enough evidence of a blatant lack of leadership at the summit.
- Calls on the government to immediately arrest the current unbearable high cost of living which is, to a large extent, caused by bad governance and incoherent government policies.



- Demands that the 2025 budget should drastically reduce superfluous and overpriced functioning expenditure as well as the government's luxurious lifestyle, in order to make those funds available for the social welfare of Cameroonians.
- Further demands that the investment budget be reflective of the real cost of the investments to be achieved and calls on the government to put an end to over the counter procurement (gré-à-gré) which is just a "legal" avenue for mass embezzlements.
- Warns the government not to further increase the cost of living through another round of fuel hikes.
- Calls on the government to assume its full responsibility and take appropriate
  measures to ameliorate the business climate in Cameroon and go a significant
  step further in local content protection as well as the promotion of "Made in
  Cameroon".
- Condemns the Government's inability to properly maintain our tarred and rural roads for which the tax-payer spends enormous amounts of money every year.
- Condemns the government's inability to play its supervisory, protective and regulatory role in the provision of water, electricity and mobile phone services to consumers and calls on government to immediately introduce significantly repressive reparatory measures to be paid by the various companies to flawed consumers for their rampant lack of service delivery.

#### C- ON THE INTERNATIONAL SCENE

- Considering the Progressive Alliance Global Convention that held in Santiago de Chile from the 4th to the 6th of October 2024;
- Considering the ongoing war in the eastern part of the Democratic Republic of Congo (DRC);
- Considering the ongoing wars in the Middle East that bear a high risk of escalating into a regional conflict;

### The National Executive Committee

- Congratulates the National Chairman, Hon Joshua OSIH, Coordinator for Africa and Dr HAOUA Madeleine and Benjamin ACHU FRU for their election as board members in the Progressive Alliance.
- Fully adheres to the new statutory framework, the Political Working Agenda, the Principles and Framework for Peace in the Middle East and the Gender Equality Action Plan as adopted at the Progressive Alliance's Global Convention.
- Fully supports President Felix Tshisekedi and the DRC in their quest to stop the war of occupation in the east of the DRC.
- Strongly Condemns all the parties in the middle east that have embarked on an insane war that has no chance of ushering in peace and calls on dialogue to be given a chance.



- Calls on the Hamas to immediately release the Israeli hostages still in their captivity and also calls on the State of Israel to put an end to the bombings and irrational killings of civilians in Gaza and Lebanon.
- Condemns the government of Cameroon's inability to establish diplomatic relations with Palestine, making Cameroon one of only two countries in Africa in that situation and reminds the government that our friendship with the State of Israel should not be a deterrent to our sovereign diplomatic mission.
- Joins the growing calls from other African countries and International agencies for a permanent seat for Africa in the UN Security Council.
